



DigitalShipper is pleased to announce that DigitalShipper 5.9.25 has been released! This release includes enhancements, improvements, and minor bug fixes. Highlighted in this document are the key changes.

IMPORTANT NOTE:

For environments currently on DigitalShipper 5.9.11 or older:

- An updated license file that is compatible with DigitalShipper 5.9.12 and above is required. The updated license must be obtained before starting the DigitalShipper update and then be imported after the update.

- 2025 carrier compliance update for UPS SurePost:
 - New rates effective January 13, 2025.
 - Updated zone rules effective December 30, 2024.
- Updated shipping label for shipments to Germany.

- Added Active Rates feature to Package Rates page to display a summary of current, non-expired Corporate and Negotiated Rates that have been imported into the environment.

UPS MAIL INNOVATIONS (UMI)

- Adjusted weight breaks for Ground Advantage (UPSMI1) and Parcel Select (UPSMIPS) for packages under one pound.
- Parcel Select Light Weight has been discontinued by the USPS.
 - Removed Parcel Select Light Weight services (UPSMIPSLWI and UPSMIPSLWM).
 - All Parcel Select services are consolidated into the current Parcel Select service (UPSMIPS).
 - Any custom service codes configured for a Parcel Select Light Weight service will need to be manually updated by a user to the Parcel Select service. This includes for any rate shop groups utilizing a custom service code configured for a Parcel Select Light Weight service.
- Added Peak Season surcharge special services.
 - Charges are based on weight, length, cube, zone, and/or demand surcharge.
 - Surcharge values must be manually configured in DigitalShipper Management Console and are effective based on configured date.
 - Automatically applied when applicable, based on package information, and when there is a corresponding special service rate greater than \$0.
- Minor adjustment to PLD file.

UNITED STATES POSTAL SERVICE CARRIER (POS)

- Minor adjustment to label workflow for USPS Ground Advantage.

DHL

- Modified DHL eCommerce shipping workflow for improved handling of international commodity information for shipment-level reporting in the outbound transaction.

APPLICATION SETTINGS

- Added option for automatic parsing for scanned dimensions.
 - When "Enable Dimension Parsing For Scanned Input" is enabled, option allows the user to scan dimensions into the Length field on the Shipments page for select dimension formats.
 - Contact DigitalShipper Support for available formats.

BATCH ORDER SHIPPING

- Adjusted workflow for site service code applied during the ship transaction when the order has been rated.

DIGITALSHIPPER HOST CONNECTOR

- Minor adjustments to message data fields.
- Added field commodity ECCN.

SITE INFORMATION

- Added Time Zone field for sites.
 - Initial value assigned based on state. This setting can be reviewed and adjusted in DigitalShipper Management Console as needed.
- Updated workflow for editable site information values.

- Updated PLD for USPS PIC numbers.
- Minor adjustment for select UPS Hundredweight DAS and EAS.

UPS MAIL INNOVATIONS (UMI)

UNITED STATES POSTAL SERVICE CARRIER (POS)

- Updated workflow for USPS API.
 - New Go Live process for POS accounts utilizing USPS API. Postal transactions must be authorized prior to shipping.

APPLICATION SETTINGS

- Updated 'Require Dimensions' option to now be two separate options: 'Require Dimensions for Generic Carriers' and 'Require Dimensions for Parcel Carriers'.

UNITED STATES POSTAL SERVICE CARRIER (POS)

- Added USPS API with support for domestic, APO/FPO/DPO, US territories (PTFAS), and international shipments.
 - The USPS is actively encouraging all eVs customers to implement the new USPS API.
 - DigitalShipper will end support for eVs transactions using the PDX upload on September 30th.
- Carrier compliance USPS price change update for select services, effective July 14.

USPS E-POSTAGE (PWT)

- The USPS and DigitalShipper are ending support for PWT on July 14.
 - Existing accounts must be transitioned to USPS API by the support-end date.

UPS MAIL INNOVATIONS (UMI)

- Added Non-standard accessorials for domestic parcel services.
 - Surcharge values must be manually configured in DigitalShipper Management Console.
 - Automatically applied when applicable, based on package information.

ASENDIA (ASC)

- Added new 'ePAQ Plus Custom' service.

- Workflow updates for multi-retailer logistics accounts.
